## **CASE STUDY OVERVIEW**

Coinsquare began using MinuteBox in 2019 to accomplish two main objectives:

- 1. The centralization of their minute books and corporate records into a single system.
- 2. A solution that could become the digital backbone of their in-house legal department.

Prior to adopting MinuteBox, Coinsquare lawyers were forced to contact their external legal counsel whenever they needed information from their own minute books; everything from a single share register to a copy of an entire minute book volume. The process was slow, expensive and often resulted in delays.

For a company so deeply dependent on technology, the Coinsquare legal team sought out a better way. Following a procurement process, MinuteBox was chosen in 2019 as the entity management platform for Coinsquare.


The process began with on-site scanning of Coinsquare's paper records. Once digitized and OCRed (Optical Character Recognition, which allows scanned pages to be searchable), the Coinsquare minute books were then uploaded onto the MinuteBox platform.

That same day, the Coinsquare team was up and running on MinuteBox — managing their entities, updating internal shareholdings and completing other corporate governance matters.

#### CENTRALIZED CORPORATE RECORDS

Within a few days, the Coinsquare legal department was able to store minute books and all of the governance data for the entities they manage. While the team chose to use MinuteBox due to its secure cloud-storage abilities, they quickly realized that the added database and document generation tools made it essential for the legal department.
